For Walls: Room for four paintings on hooks (two additional smaller paintings may be displayed using fishing line or wire loops from the bottom hooks).

For Racks: Drapery hooks, which are furnished by League in basket on entry table.

Show dates:

November 27, 2016 (Sun.) to January 8, 2017 (Sun.)

Show Hours:

9 AM to 4:00 PM weekly 1:00 PM to 4:30 PM Sunday – when Park is open.

Reception:

November 27 (Sunday) at 1:30 PM to 4:00 PM

Participating artists should bring a finger food on appropriate serving tray with utensil to the reception by 1:15 PM.

January 10, 2017 (Tues.) 9:00 A.M. to 4:00 P.M.

Instructions:

Spaces will fill in order of received applications. When exhibit is filled, applications will be returned. All applications and a \$15.00 fee must be turned in to WVAL by Sunday, **November 13**. WVAL show rules apply. Attach identification cards to the left front and left back of all artwork. Artists are limited to two rods with hooks wall space no larger than 48" width or height. Artwork must remain at the show until January 10, unless sold.
