 Reception: June 11
 Show Fees: Fees for the Judged Show is \$15.00 for the first piece and \$10.00 for the second piece submitted.
 Awards: Best in Show \$250.00, Second Place \$150.00, Third Place \$125.00, Honorable Mention \$75.00 , Award of Excellence \$50.00, Memorial Awards \$25.00. Three People's Choice Awards will be announce at the reception.

- Rules:
1. Must be work of current Watauga Valley Art League Member.
 2. Entries must be original in concept, design and execution and must be properly framed and wired for hanging.
 3. Entries should be not larger than 48: in any dimension and finished in the last two years
 4. Fill out two identification cards, place on on the upper left corner on back and give the second to the show coordinator.
 5. Artwork that has previously won awards in the WVAL Summer Art Shows are ineligible for entry.
 6. Entries are not to be removed from the show until June 26, 2023 unless sold, in which case the ribbon and name of artwork should remain in place.
 7. All applications should be received no later than June 5, 2023
 8. Checks need to be made payable to Watauga Valley Art League.
