The Watauga Valley Art League will meet Saturday, April 19, 2014 at the Johnson City Memorial Park Community Center, 510 Bert Street, in Johnson City from 11:00 am until 1:00 pm. An informal art critique begins at 10:30 am for those interested, as well as a time of fellowship and refreshments.

The speaker for the April WVAL meeting will be David Kramer. Mr. Kramer will be giving a presentation on Photoshop, which he has used throughout his years of being a commercial artist. In his career he explored Photoshop's many facets and uses for photo retouching, illustration, and color correction. Intriguing him now is the application of this digital photo program applied to painting. Using its' many nuances, Photoshop can color correct an artist's reference photo and it can be used for color mixing, combining multiple photos into one picture, plus numerous other capabilities. Mr. Kramer will be giving a 45 minute Photoshop presentation on ways that an artist can prepare for executing a painting. Typed handouts will be available.

Mr. Kramer has worked in the commercial art field for various toy companies, IBM, Honeywell, Dairy Queen, Happy Chef, and other industrial manufacturers. He thinks of his background as wonderful learning years which have evolved now into a self-expressive stage of personal art.

PROGRAM: Leslie Davis, Plein Aire Painting Leslie articulated the 'Plein Aire' principles with the aid of computerized pictures, excellent communication skills, and two handouts. Leslie emphasize that Plein Aire actually upholds the thought 'the heavens upholds the glories of God.' Her techniques evolved around successful landscapes using the following tools: the ability to select a subject/topic; color usage and values; how to use oil paints effectively; photographs; using black and white paint

before any color is added; selecting the appropriate setting; and, the freedom to eliminate and change within any given painting. Of course, she also shared about the tools needed. Leslie was simply outstanding in her program making everyone think, 'Yes...I can do it.' Leslie has a rare gift of communicating mixed with objectivity and humor, especially the 'Three P's' she mentioned. The group interacted positively after the meeting showing and exemplify a program well done. It was fantastic! It certainly is a means to an end using the idea of 'light and dark' bring life to a painting within the studio.
