Betty Stapleton – "Vera-fied by Critique Show" at the Renaissance Center in Kingsport during the month of May with the opening reception April 27, 2-4 pm. Exhibiting artwork will be Diane Allen, Don Gotterbarn, Sharon Neuhaus and Betty Stapleton.
